The Chief Inspectorate of Road Transport of the Republic of Poland informs that:

- the penalty amount is determined by the relevant authority on the basis of the „tariff” – it is not possible to reduce or increase the amount beyond the limits specified in the regulation¹;
- if the vehicle was sold before the date of the offence, please send a copy of the document confirming the sale along with legible details of the buyer / recipient (copy of the contract, invoice, donation deed). The attached document must be translated into Polish.

Please send your responses on the attached forms.

Only a penalty notice is the basis for the payment of the penalty.

Payments should be made **using on-line banking systems or at outlets of entities that enable transfers** to the INDIVIDUAL bank account number indicated on the payment form.

CODE OF PETTY OFFENCES

(Journal of Laws of 2023, item 2119, as amended)

Article 38 § 2. A fine in the amount not lower than twice the lower limit of the statutory risk shall be imposed on a driver of a motor vehicle punished for the offence referred to in Article 86 § 1a and 2, Article 86b § 1, Article 87 § 1, Article 92 § 2, Article 92a § 2, Article 92b, Article 94 § 1 or Article 97a, who commits the same offence within two years from the last final punishment.

HOW TO CHECK AUTHENTICITY OF A NOTICE SENT BY POST?

- the notice is sent by registered mail – the Chief Inspectorate of Road Transport never sends it by mail without confirmation of receipt³ nor by electronic means of communication;
- the bank account number includes numbers (from 3 to 10) **1010 0055** – this is the number of the account at the National Bank of Poland, which holds accounts only for public entities;
- the seal with the emblem on the notice is clearly convex, made using dry stamp technology.
